3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Clients in the project will come from the CoC Coordinated Entry and Prioritization list in the order determined by the CoC. Clients in this project will meet the definition of DedicatedPLUS - 100 percent of the beds will be dedicated to serve individuals with disabilities and families with one adult or child having a disability, including unaccompanied homeless youth. The project will follow the Housing First model to assure that no barriers are in place that would screen out otherwise eligible individuals and families. This will allow entry into the project regardless of client income, current/past substance use, history of victimization (e.g., domestic violence, sexual assault, childhood abuse, human trafficking), and criminal history—with the exception of restrictions imposed by federal, state or local law or ordinance (e.g., restrictions as to where persons on the sex offender registry may reside). The project will be scattered site with the bulk of the units in the City of Racine, but some units may be secured in other areas of Racine County. The project is designed to provide 1 SRO unit, 21 units of one-bedroom, 6 units of two - bedroom, and 3 units of 3 bedroom scattered-site permanent supportive housing (PSH), supportive services and basic needs assistance to homeless persons. The project will provide case management services; and will utilize motivational interviewing and trauma informed care methods. Clients will be able to access additional services offered by numerous community agencies both at the HALO shelter and elsewhere in the community. Resources and workshops include access to and assistance in obtaining mainstream resources, budget/financial planning; anger, time and stress management; landlord/tenant; basic life skills training; work skills and employment training; legal assistance; as well as connecting veterans to private nonprofit, VA and State DVA services; domestic violence survivors to local domestic, child and sexual abuse providers including those funded with Federal VOCA and VAWA funding; and youth 18 - 24 to local youth advocacy groups. Connections will also be made to the LGBTQ Center, AIDS Resource Center, McKinney Vento liaison at appropriate school district and other specialized organizations and services. The target goals of the project will be within the performance measures set by the CoC.
