Explain the circumstances that led HUD to recapture funds from the most recently expired grant term related to this renewal project request.

An amount of \$650 in rental assistance was paid in June 2017, but was a charge for the rapid rehousing participants rent for the month of July 2017. This appeared as part of voucher number 501-00322202 submitted on 7-12-2017. After internal discussions, the recipient wrote to the HUD field office to determine whether this was an allowable expense for the grant period, effectively self-identifying and self-reporting the issue. After determining that the expense should not have been charged for the June 16 - June 17 grant period, the recipient returned the funds, initially attempting a wire transfer using information provided by HUD. That was not successful and the recipient returned the funds by check number 5366 dated 10-30-2017.

The HOPES Center Rapid Rehousing 1 serves families with children who meet the category one definition of homelessness. The project actively uses the Continuum of Care's coordinated entry system. All households are selected from the Racine Housing Prioritization List (Families) based on the highest service needs (VI-SPDAT score) and then length of time homeless at the time of selection. Both WISP and Non-WISP prioritization lists are consulted prior to selection.

HOPES Center Rapid Rehousing projects (including an State of Wisconsin ETH Rapid Rehousing Project, this project, and two other HUD / COC Rapid Rehousing projects) have selected participants from the following shelters through coordinated entry: Homeless Assistance Leadership Organization (HALO), Women's Resource Center (WRC), and Transitional Living Center of Burlington (TCL). HOPES has also selected clients who were living in places not meant for habitation at the time of project entry. HOPES Center has worked with the shelters to coordinate services with participants while they are in the process of identifying and entering permanent housing.

Clients' income is assessed every six months and clients are required to contribute 30% of their adjusted income towards their housing expenses. Clients are encouraged to work towards a goal of housing stability and taking over financial responsibility for their rental payment within six months of entry into permanent housing. Because HOPES selects participants with the highest service needs this is not always possible and clients may revise housing stability plans at six month intervals and receive rental assistance up to a maximum of 24 months.

Participants attend one meeting with a case manager per month. Supportive services are offered on a voluntary basis and according to a housing stabilization plan. HOPES Center Rapid Rehousing participants have received services from Racine Vocational Ministry (employment services), Legal Action of Wisconsin (Legal Services and Benefit Applications), and mainstream services through Workforce Development and Behavioral Health Services (Racine County), and Division of Vocational Rehabilitation (State of Wisconsin). HOPES Center also has licensed mental health providers that have provided counseling to rapid rehousing participants.

The project selects household through coordinated entry based on the highest service needs at the time of selection. Because no sub-population is targeted, it is impossible to project to which sub-populations project participants may belong. Because a large number of households are referred to the Racine Housing Prioritization List (Families) by the Women's Resource Center, it is reasonable to expect that some of the households will be victims of domestic violence or fleeing domestic violence. Because the project selects families with the highest services needs, it is also reasonable to expect that some of the participants will have members that suffer from a severe mental illness and or chronic substance abuse. Because of the availability of other housing services specifically targeting veterans and a lower representation of veterans in the shelters referring to the families list, it is less likely that participants will be homeless veterans. Permanent Supportive Housing prioritization lists prioritize people who are chronically homeless, whereas rapid rehousing prioritization list prioritize service needs regardless of whether or not the household is experiencing chronic homelessness, which also appears more common on the singles list than the families list.
