3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The HOPES Center Rapid Rehousing 2 serves families with children who meet the category one definition of homelessness. The project actively uses the Continuum of Care's coordinated entry system. All households are selected from the Racine Housing Prioritization List (Families) based on the highest service needs (VI-SPDAT score) and then length of time homeless at the time of selection. Both WISP and Non-WISP prioritization lists are consulted prior to selection.

HOPES Center Rapid Rehousing projects (including an State of Wisconsin ETH Rapid Rehousing Project, this project, and two other HUD / COC Rapid Rehousing projects) have selected participants from the following shelters through coordinated entry: Homeless Assistance Leadership Organization (HALO), Women's Resource Center (WRC), and Transitional Living Center of Burlington (TCL). HOPES has also selected clients who were living in places not meant for habitation at the time of project entry. HOPES Center has worked with the shelters to coordinate services with participants while they are in the process of identifying and entering permanent housing.

Clients' income is assessed every six months and clients are required to contribute 30% of their adjusted income towards their housing expenses. Clients are encouraged to work towards a goal of housing stability and taking over financial responsibility for their rental payment within six months of entry into permanent housing. Because HOPES selects participants with the highest service needs this is not always possible and clients may revise housing stability plans at six month intervals and receive rental assistance up to a maximum of 24 months.

Participants meet with a case manager once per month. Supportive services are offered on a voluntary basis and according to a housing stabilization plan. HOPES Center Rapid Rehousing participants have received services from Racine Vocational Ministry (employment services), Legal Action of Wisconsin (Legal Services and Benefit Applications), and mainstream services through Workforce Development and Behavioral Health Services (Racine County), and Division of Vocational Rehabilitation (State of Wisconsin). HOPES Center also has licensed mental health providers that have provided counseling to rapid rehousing participants.

The specific population focus of this project is families with children. Because the coordinated entry prioritization list for rapid rehousing prioritizes based on service needs (VI-SPDAT score) and not chronic homelessness, we expect few people who are chronically homeless, who would be prioritized for permanent supportive housing. The number of veterans on the families prioritization list has been few, so we expect few veterans. Although we expect some people with issues related to mental illness or chronic substance abuse, we do not know to what sub-populations participants will belong. The unlisted subpopulations would represent people or children who are homeless, prioritized through coordinated entry, but do not fall into a specific subpopulation.
