3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This Racine CoC Coordinated Entry System will use multiple access points. At each access point participants will receive a standardized pre-screening and assessment approach. All persons will be able to access CE at The HOPES Center or Homeless Assistance Leadership Organization (HALO). Participants sleeping in emergency shelters will be connected to CE through the shelter case managers. Participants sleeping on the streets will be connected to CE through street outreach workers. When persons fleeing domestic violence present at any access point, the participant will have the option of connecting with a services specifically designed to meet the unique needs of the subpopulation or using the general CE system.

The CE system will utilize a standard assessment approach. All participants in need of permanent housing will be assessed using the most recently released version of the VI-SPDAT, VI-F-SPDAT and TAY-VI-SPDAT. The assessment process will be client-centered and allow for participant autonomy. Assessments will take place at all access points. All staff conducting assessments will be trained so that all assessments are conducted in the same manner. Assessors will use culturally and linguistically competent practices, and will conduct trauma-informed assessment of participants.

The referral process will be conducted through the HMIS and a Non-HMIS tool. Staff at each access point will make referrals to the housing priority list, and staff at permanent housing agencies will accept referrals from the priority list. The CE project contact will oversee the referral process, and will direct the case managers and outreach workers to follow-up with participants on the priority list. The CoC CE system will use standardized housing placement prioritization that will be determined through a report generated through HMIS and the Non-HMIS tool. This report incorporates the housing prioritization ranking criteria. The CE system will utilize housing placement meetings for singles and families in order to allow case workers an opportunity to provide additional information needed for housing prioritization.

The CE System will use multiple access points. Information about access points will be provided to potential participants via food pantries, health clinics, mental health providers, schools, and law enforcement. Information will also be provided through the county workforce development center and on the Racine CoC website. Street outreach workers will connect participants living in places not meant for habitation to the CE System. Advertisement materials will be available in English and Spanish. The CE System will utilize a language access phone line to ensure that all participants are able to receive assistance through

Staff at each access point will make referrals to the housing priority list, and staff at permanent housing agencies will accept referrals from the priority list via case conferencing meetings. The CE project staff will oversee the referral process, making sure the access points make referrals for homeless participants and that housing agencies are taking referrals off the list. The CE project staff will also direct the case managers to follow-up with participants on the priority list to determine if the participants are still in need of housing and need to remain the priority list. The CE System will also utilize bi-weekly housing placement meetings to prioritize participants. These meetings will be managed by the CE project staff. Housing placement meetings will provide case workers an opportunity to provide additional information needed for housing prioritization.
