- **3. Presentation**: Diane Rogstad, Outreach and Marketing Supervisor, Aging & Disability Resource Center of Racine County "Linking People to Services, ADRC of Racine County"

Community resources for seniors and caregivers.

- ADRC is committed to providing unbiased information and resources, providing three or more options for callers to make informed decisions.
 - Information and assistance specialists ask detailed questions to connect callers with the right resources, regardless of income level or support needs. They provide personalized support for seniors and caregivers, including resources and benefit information.
 - Resources available in Racine County include the Community Resource Directory, Living Options Directory, and Dementia Resource Directory.
 - o Living Options Counseling is available to help individuals and their supporters make decisions tailored to their needs, with a focus on person-centered care.

Elder care options and support services.

- Aging and Disability Resource Center provides individualized support for caregivers and individuals receiving care, with a focus on choice and self-determination.
- Caregivers can access support groups, classes, and resources for respite, as well as benefit specialists who can help with disability and senior care benefits.

Senior housing and care options in Racine County.

• Senior Nutrition Program offers delivered meals and congregate meals at three locations, with referrals and participation voluntary. Information on housing resources for seniors in Racine County, including subsidized housing options and contact numbers. There are different types of long-term care facilities, including adult family homes, CBRFs, and nursing homes, and their varying levels of care and staffing requirements. Diane emphasized the importance of keeping individuals in their homes for as long as possible with the support they need, rather than transitioning directly to a nursing home.

Resources for seniors with disabilities.

- ADRC assists with applications for Social Security, SSI, and low-income housing, and helps with appeals if denied.
- Browns adult daycare offers walk-in showers and laundry services for seniors with disabilities

Transportation resources for seniors and people with disabilities.

- Transportation options in Racine County include city bus and specialized door-to-door service K Town, with varying costs and eligibility requirements.
- In-home care is the most in-demand service provided by the organization.
- Independent Living Center provides adaptive equipment for people with disabilities, including shower chairs, wheelchairs, walkers, and portable ramps.
- Case managers can meet with clients to discuss their needs and provide equipment and resources for independence.

Long-term care resources and eligibility.

- Kim Meitner is a dementia care specialist who provides resources and support for individuals with memory loss, including those with Huntington's and Parkinson's.
- Behavioral Health services offer a mobile crisis unit that can be contacted for questions and support, and case managers can work with this unit to provide comprehensive care for clients. Case managers work at assessing functional and financial eligibility for long-term care services.
- It is important to determine whether a person's disability or mental illness is the cause of their inability to perform daily living tasks.

Resources for hoarding, housing, and mental health.

- Hoarding resources available in the area, including cleaning and mental health support.
- Landlords can call ADRC for resources to help tenants with hoarding issues, without needing permission.

Senior resources and long-term care programs.

- Resource directory for people with disabilities includes information on support groups, transportation, and medical services.
- Iris is a long-term care program for Medicaid-eligible individuals with functional needs, but cognitively impaired individuals may not be a good fit without a guardian or family carer.
- Family Care Partnership is a Medicare and Medicaid waiver program for individuals with complex medical needs, including the ability to add a nurse practitioner to their care team.
- The PACE (Program of All-Inclusive Care for the Elderly) is primarily for seniors and provides comprehensive medical and social services at one location, including transportation and prescriptions.

Resources for Medicaid recipients in Wisconsin.

• Diane provided insights on resources for Medicaid and dental care, including sliding scale fees and discounts.
