The meeting was called to order by Teresa Reinders at 9:02 a.m. with welcome and introductions.

#### 1. Consent agenda

a. Approval of consent agenda. Pam Handrow moved to approve, Holly Anderle second.

## 2. New business

- a. Youth Housing Demonstration Project (YHDP) Request for motion to approve an initial application to HUD competition for eligibility to apply NOFO. Pam Handrow approved, Jori Chambers second with Brendan Saunders and Jenny von Helms abstained, and are able to support the YHDP motion.
- b. Discussion YHDP is a special grant from HUD which recognized the special concerns surrounding youth ages 18-24. The nationwide competition we are voting on is an initial step required and utilized by HUD to decide which CoCs are eligible to receive funding for housing projects under this grant.

**Presentation:** Great Lakes Community Conservation Corps: Gene Kennedy, Operations Director – CERT School Milwaukee and Racine. Along with Mathew White, Director of Agvets of Southeastern WI. Pat Adams, previous Airforce nurse and current social support for participants will present on behalf of the Great Lakes Community Conservation Corps.

Racine CoC recently wrote a letter of support for the Great Lakes Community Conservation Corps and the electronic free library that is being utilized in Racine.

Great Lakes Community Conservation Corps continues the Civilian Conservation Corps tradition to address climate change and advance green living, and provide needed education and training for disadvantage populations in the great Lakes are. There are two locations for Veteran's Corps and Cert High School.

- Go Solar program offers a significantly discounted solar panel system installation to encourage renewable energy use and reduce carbon dioxide emissions into the atmosphere.
- Reduce The Runoff program provides free landscaping to qualified recipients to minimize rainwater pollution from runoff and increase our waterways' health.
- The Certification and Emergency Response Training (CERT) High School has locations in Racine and Milwaukee and works as a hybrid career academy that trains students to be first responders and prepare for occupations in the transportation industry. This program is for 18-20 years old and uses the classroom and field training technics.
- Veterans Corps and Ag Veterans programs help with transitioning into civilian life. Our veterans' services build on military experience, promote a sense of purpose, provide peer support, develop job skills training, and instill self-confidence.
- Electric Free Library. This is a station where a person can charge their phone. This was a community activity to provide a free service during natural disaster and for those who are homeless. There will be more of these libraries installed throughout our community during the summer. One is located at 1437 Marquette Street and Mitchell School in Racine.
- A grant from United Way of Racine County allowed a total of 27 raised beds and the gardens initiative for veterans. The goal of the initiative is to engage physically and in conversation with the veterans.

There are many tiers for veterans to support local veterans in continuing their mission by acquiring career-ready skills, serving the community and providing support in life after the service.

- Volunteer activities unpaid. Veteran volunteer now and then or at events.
- Auxiliary-flex paid up to 25 hours per week.
- Full-time paid. This is for veterans who are committed to fining regular employment. They can use this program as a stepping stone.

There is transportation available to veterans in these programs.

- Meet and greet opportunities.
- Gain familiarity with the Veteran's Crops.
- Transition into the Auxiliary-Flex Time option.

  - O Safe Harbor for every veteran to learn and earn.
