- a. <u>Coordinated Entry Committee</u> Chair: *Iraida Vazquez (ICA)*. The group has moved forward to review the assessment process and forms. They currently are updating the Coordinated Entry Written Standards.
 - i. <u>CoC Point-in-Time</u> *Chair: Scott Metzel*. The group held their initial meeting and determined the methodology which will be the same as in previous years.
