#### 4. New business -

a. Collaborative Applicant update

Teresa: Process to apply and receive funding and complete planning grant for what we do as the Racine CoC. HALO notified us that they were going to need to step aside and opened up the application process. Filled out application process, met with them and had the interview and chosen to select county as the next CA. Next steps will be us meeting with the

Mary Beth question: When will it be effective? Earliest would be February 1st but is in process of meeting to determine the timeline.

Mary Beth question: As the collaborative applicant, does the County get a percentage of the grants? County would be required to come up with match funds for the planning grant and unsure what amount of planning grant they would receive or how that works, Teresa states this is beyond her knowledge. This will be written in the MOU and the County would be aware of this before taking on this role. Bethany Apartments was the first Collaborative Applicant in Racine. United Way and LAW have also previously been collaborative applicants in the past for Racine CoC so this is not new.

b. 2025 Proposed meeting schedule and format of meeting

Set schedule for 2025 for the CoC membership meetings, the option is to continue to meet every other month or move to a quarterly meeting schedule. Open for discussion. Governance documents indicate we must meet at least quarterly.

The dual identity issue – need to be one ruling body and the Alliance is the CoC membership group, and the officers are responsible for both. Not sure if this requires a motion or not but to be safe, motion will be entertained.
