Notification of acceptance or rejection will be sent to applicant via email and posted on the CoC website by <b>September 12, 2023</b> - (HUD requires public notification of project acceptance, rejection, priority 15 days before HUD submittal deadline.)  |
| <b>Friday, September 22, 2022, by 11:59:59 PM CST</b>  | <b>Final New, Bonus &amp; Renewal Project Applications Due in e-snaps</b> | <b>Last date for any modifications/corrections to applications and resubmittal</b> in e-snaps after rating and ranking final appeals and threshold reviews.<br>Submit copy of final e-snaps version as pdf to <a href="mailto:racinecocorg@gmail.com">racinecocorg@gmail.com</a> (use subject line: "Agency Name" Final e-snaps Copy)   |
| <b>Monday, September 25, 2023</b>  | <b>CoC Consolidated Application Posted</b>                                | <b>CoC Consolidated Application and Project Applications posted to the CoC website by Monday, September 25, 2023.</b> Public comment period of 2 days is required by HUD.   |
| <b>By Thursday, September 28, 2022, 7:00 PM CST</b>  | <b>Submission of FY223 CoC Consolidated Application</b>                   | <b>Official due date is September 28, 2023, 08:00 PM EST (07:00 PM CST)</b>   |
