  - a. PIT took place on January 26, 2022. There were several teams from HALO, Hope Center and Bethany Apartments that helped out. The last team was in about 2:00 a.m. with a sweep after that. The unsheltered count is expected to be at 7.

**Presentation:** Teresa Reinders lead a discussion regarding CoC structure, goals and happenings.

What tasks or ask of does CoC need of the members.

- Teresa is working on a youth initiative to present at local schools

- Volunteer opportunities; committees within CoC

Discussion on community resources.

- It was suggested to start a Google document for Alliance partners. Alliance partners would share program information for homelessness in Racine County.
- Past Leadership Racine projects created a resource directory.

Fight to End Exploitation (FEE) received a grant to provide youth services. Potential working with SAFE Haven, Bethany Apartments and Women's Resource Center to expand youth services. As FEE will report back to this group with findings.

Iraida and Teresa are working on the qualitative data. Working with a HUD DA representative to obtain stories from clients who have experienced trauma. The goal is to have qualitative information to tell the story and have meaningful information to share.

• Contact HALO staff to identify clients to interview or interview staff.

Continue to evaluate coordinated entry; what process does the client experience. Clients could be afraid to get services because of the personal information that one needs to share at intake. The information could be 'leaked' to government sources is a fear for some.

Fight to End Exploitation (FEE)

FEE is expanding youth services by providing teen dating resources.

### Racine Revitalization Partnership

RRP Night Market is scheduled for June 4 at 1601 Washington. There is a capacity of 72 vendors, food trucks and they are in search of f band to play.

There is one house available.

#### HALO

Currently, 113 people under shelter. HALO has reduced the number of hotel vouchers available. HALO is taking people and working the best they can.

### Hospitality Center

The center has conducted site visits with Catholic Charities and HALO and other communities' resources that have coordinated resources operating. The goal is to bring a Coordinated Resource Center in Racine.

Hospitality Center is open for breakfast and lunch. Serving 80 - 100 meals a day with option to take place to go. Encouraging everyone to take meals inside to eliminate the garbage waste outside.

Hospitality Center is also a pop-up clinic. Since opening the pop-up clinic there was 180 people that was vaccinated.

### Legal Services

Case load continues; clients are receiving notices due to landlords selling their properties.

#### RIJSD

We have funds from the government to purchase items for homelessness children in the RUSD district. These funds were set aside to partner with community resources and work with the housing navigator. There are 615 children in the case load. There is also title one teacher to assist with reading and math intervention. Funding support direct the work with students.

### Hope Center

By appointment or office hours; Tuesday – Friday 8-2 p.m. Two nights a week at night. During the cold weather, outreach is out there.
