The federal McKinney-Vento Homeless Assistance Act protects youth's right to stay in their school. There is support for families experiencing homelessness—including those doubled up with others after losing their own housing—that address the education rights of their children, which are protected under federal law. Youth that are homeless may be sharing the house with others, living in motels, living in emergency or transitional shelter, living in public or private place, children from migrant families who qualify, unaccompanied homeless youth (youth living relatives on an emergency basis, youth living with a friend of runaways.

Children and youth that are homeless may struggle with achievement gap, poor classroom engagement and poor social skills and high incident of dropping out of school. There are many barriers to youth homelessness; poor health, fatigue, hunger, emotional trauma, depression, anxiety, stereotypes and lack of awareness, under-identification, high mobility resulting in lack of school.

Homelessness youth could be identified during the school enrollment process or school staff suspect youth who are homelessness. All families in transition qualify for Title 1.

No proof of address is needed with an address change. Families can simply tell the liaison of the address change. The student can remain in the original school of enrollment. Transportation to school of origin is provided.

The liaison helps families complete the registration/enrollment process. There are no forms that are required to enroll. Typically, youth qualify for free lunch. Eligibility can only be determined by the homeless liaison. This could take 15 minutes to a couple of hours depending on the family. Confidentiality is important. Student's living situation should be considered confidential. It is the responsibility of the student/family to decision to share this information with anyone. The principal of the school may know that knowledge. Families must reapply each school year. Families receiving services for the entire school year-even if they do become permanently housed.

There are many services offered once enrolled; school supplies, access to community agency referrals/information, field trip funding. Field trip funding is limited. Help to secure cap and grown for seniors. Students are able to stay in the same school.

There are many ways to help youth homelessness; be familiar with signs of homelessness, update the FIT coordinator, share information about McKinney-Vento Act, educate-educate everyone and anyone about Families in Transition program. Community Schools help address the homeless youth by supporting all families in the community school neighborhoods. Pre COVID-19 Knapp and Julian Thomas community schools started the walking school bus to encourage attendance.

## At a glance

- Graduation rates: students identified as FIT anytime during their high school career are roughly 20-30% less likely to graduate.
- Wisconsin statistic; Public school data reported to the U.S. Department of Education during the 2017-2018 school year shows that an estimated 18,853 public school students experienced homelessness over the course of the year. Of that total, 316 students were unsheltered, 2,257 were in shelters, 1,176 were in hotels/motels, and 15,104 were doubled up.
- RUSD
  - o Had 894 homeless youth in 2018-19.
  - o 4.3% of RUSD Students for the 2019-20 school year were identified as homeless.
  - o Is receiving CARES funding to address youth homelessness.
