(2) LSS received ESG-CV outside of the collaborative application for Homeless Prevention and Rapid Re-Housing. The Emergency Solutions Grant (ESG), Housing Assistance Program (HAP), and Homeless Prevention Program (HPP) are collectively referred to as **the EHH Program**. ESG is Federally Administered by the United States Department of Housing and Urban Development (HUD). HUD awards ESG funding to the State of Wisconsin, Department of Administration, Division of Energy, Housing, and Community Resources (DEHCR) to distribute to eligible applicants. HPP and HAP are State of Wisconsin funding sources. The Housing Assistance Program, formerly known as the Transitional Housing Program (THP) was re-named under 2017 Wisconsin Act 59

There was a data migration to a new database. The data migration took place and HMIS is in the process of reviewing information.

Continuum of Care Interim Rule, formalizes the following CoC Responsibilities

- Coordinating, or be involved in the coordination of, all housing services for persons experiencing homelessness within the geographic area.
- Coordinating McKinney-Vento funds awarded within the geographic area.
- Establishing and Operating the HMIS within its geographic area
- Establishing and operating, or designating, the centralized/coordinated assessment to be used within its geographic area

There are written standard to follow and task that are done by several committee members includes; housing providers, emergency shelter/street outreach providers, supportive services providers, HUD and Non-HUD funded providers, person with lived experience and HMIS Lead.

Coordinated entry system goals include: easy for the client and provide quick and seamless entry into homelessness services, referred to the most appropriate resource(s) for their individual situation, prevent duplication of services, reduce length of homelessness, improve communication among agencies.

Benefits of coordinated entry help persons at risk and experience homelessness and streamlined housing and supportive services projects. Public and private funders are confident that housing and supportive services projects are serving the intended people. Information is shared to improve and act on better outcomes/system performance.

Coordinated entry data was shared such as:

- Homeless by household type
- Homelessness by household type per coordinate entry list
- Racine CPC Coordinated entry historical data
- Coordinated entry historical outcomes
- Gender by household type
- Race by household type
- Gender, race, and ethnicity by household type

## Racine COC needs:

- Landlords willing to lease unites to permanent housing program participants and self-paying clients
- Risk mitigation funding
