New business

- a. A few updates from COC Director:
 - i. WHEDA Emergency housing Voucher program. We are in the process of preparing our agencies on the requirements for preparing clients for referral.
 - ii. Eviction Moratorium. It is adjusted and following CDC guidelines. Clients in need of funding for eviction contact R/K Community Action Agency.
 - iii. COVID-10/Delta variant resurgence and ESG-CV requirements for serving at shelters. Shelters cannot deny services to ref to get tested, to wear a mask or get a vaccine. We recommend shelter programs have to make a arrangement within policies and isolation those individuals.

 - a. 20 23 people attend monthly
 - b. Collective sigh when we didn't meet in July
 - c. Continue to be virtual; having a group over 20 in size, moving forward using live streaming to include more folks.
