CVI serves as the CoC's Coordinated Entry (CE) portal for homeless veterans; and the CVI project is the only Racine CoC veteran-exclusive project. Participants are selected from the CE Prioritization List based on highest service needs (VI-SPDAT score). The project provides PSH services to 18 single, homeless disabled adults, in an 18-unit one-bedroom CVI-owned apartment building, containing common areas and laundry amenities, under a Housing First model. Eighty-three percent (83%) of the units are designated for disabled veterans and the remaining for disabled non-veterans; all units are dedicated to the chronically homeless. Approximately 90% of the participants have remained in PSH more than a year; more than 50% addressing two or more physical/mental health conditions; and 75% 55 years of age or older. The case manager assists the veteran to develop/update a service plan based on assessed needs for independent living; and connects, coordinates and monitors the appropriate services to support the participant's housing stability and achievement of other individual identified goals. Inordinate individualized case management attention is given to support participant efforts for independentliving and strengthening life skills; and participants are encouraged and supported in efforts to participate in the labor force, at their level of ability. The project location is ideal for taking walks; accessible public transportation to Lake Michigan, parks, beaches, museums, community festivals/events, shopping, community engagement, volunteer activities; and other community resources. Project services – directly and/or via referral - include medication management; relapse prevention support; crisis intervention; health care/mental health/substance abuse treatment; financial management; life skills training; education assistance; employment/work therapy; aftercare referrals; veterans' benefits, SOAR/SNAP and other mainstream resources. Veterans are connected to: VAMC (intensive mental health, substance abuse and related health services, Milwaukee), Community-based Outreach Clinic (CBOC, mental health, Racine County) and HUD-VASH, as appropriate; Racine County Veterans Resource Center (VRC/CVI, veteran counseling/benefits; SSVF, computer lab and legal services); Veterans Outreach (furniture, food); Veterans Motorcycle Club (food); and CoC member services. Non-veterans are connected to community resources and CoC member services. Projected Outcomes: 1) 85% of participants will remain in PSH or exit to permanent housing; and 2) 60% of participants will maintain or increase their income (all sources). The Project supports the following goals of the COC, US DVA, HUD, and community's 10-year plan to: provide services to chronically homeless; increase the PSH options within the CoC; increase outreach to homeless individuals; and decrease the incidence of homelessness in the community.



- Housing Fees. Grant funds can be used to pay fees associated with getting survivors into a safe unit via emergency transfer(s), including but not limited to application fees, broker fees, holding fees, trash fees, pet fees where the person believes they need their pet to be safe, etc.

- Case Management. Grant funds can be used to pay staff time necessary to assess, coordinate, and implement emergency transfer(s).

- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).

- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.

- Monitoring and evaluating compliance.

- Developing and implementing strategies for corrective actions and remedies to ensure compliance.



Contracts/grants providing for ceilings as to the indirect cost rate(s) or amount(s) which are indicated in Section I above, will be subject to the ceilings stipulated in the contract or grant agreements. The ceiling rate or the rate(s) cited in this Agreement, whichever is lower, will be used to determine the maximum allowable indirect cost on the contract or grant agreement.
- 8. Administrative costs consist of all Direct and Indirect costs associated with the management of a non-Federal entity's programs. Non-Federal entities should refer to their contracts/grants terms and specific program legislation for the applicable definition of Administrative Costs and any related limitations.

# B. ACCOUNTING CHANGES

This agreement is based on the accounting system purported by the non-Federal entity or contractor to be in effect during the Agreement period. Changes to the method of accounting for costs which affect the amount of reimbursement resulting from the use of this Agreement require prior approval from the Cost & Price Determination Division (CPDD). # D. DEFINITION OF RATES

- 1. Final rate means an indirect cost rate applicable to a specified past period which is based on the actual costs of the period. A final rate is not subject to adjustment.
- 2. Provisional rate or billing rate means a temporary indirect cost rate applicable to a specified period which is used for funding, interim reimbursement, and reporting indirect costs on Federal awards pending the establishment of a final rate for the period.
- 3. Predetermined rate means an indirect cost rate, applicable to a specified current or future period, usually the organization's fiscal year. The rate is based on an estimate of the costs to be incurred during the period. A predetermined rate is not subject to adjustment.
- 4. Fixed rate means an indirect cost rate which has the same characteristics as a predetermined rate, except that the difference between the estimated costs and the actual costs of the period covered by the rate is carried forward as an adjustment to the rate computation of a subsequent period.

The Special Remarks section of this agreement may include a carry forward amount(s) for the applicable fiscal year(s).

5. G&A rate – If published in Section I, it is the acronym for "General and Administrative" type of indirect expenses. G&A means any management, financial, and other expense which is incurred by, or allocated to, a business unit and which is for the general management and administration of the business unit as a whole.

# E. SPECIAL REMARKS

1. Provisional/Final Rate approval and impact to closeout adjustments:

When seeking initial reimbursement of indirect costs using the provisional/final rate methodology, a provisional proposal must be submitted within 90 days of receiving a Federal award (financial assistance, grants, cooperative agreements, and cost reimbursable contracts) that requires accounting for actual costs incurred. The non-Federal entity or contractor must submit an indirect cost rate proposal within six (6) months after the end of their fiscal year to establish a final rate.

Once a final rate is negotiated, billings and charges to Federal awards must be adjusted if the final rate varies from the provisional rate. If the final rate is greater than the provisional rate and there are no funds available to cover the additional indirect costs, the non-Federal entity or contractor may not recover all indirect costs. Conversely, if the final rate is less than the provisional rate, the non-Federal entity or contractor will be required to reimburse the funding agency for the excess billings.
