Once that grant ended we were able to allocate some costs to the new contract year, but werent able to submit until the 2nd quarter of that grant.

As part of a CoC move on strategy, EHV (Emergency Housing Vouchers) were used. Many of the clients retained their units with EHV vouchers, which created a need to locate units when they exited from the PSH program. It then took longer to lease up new units than we anticipated due to a number of factors including fewer rental units being available in general, and fewer being available within the FMR. We were able to move some of the funding to other categories, but there were remaining funds.



- Case Management. Grant funds can be used to pay staff time necessary to assess, coordinate, and implement emergency transfer(s).

- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).

- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.

- Monitoring and evaluating compliance.
