Operational duties include attendance at CoC & committee meetings, & coordination of monitoring & evaluation of the performance of CoC & ESG funded projects. HMIS duties include coordinating with the HMIS Lead Agency to monitor participation in HMIS, reviewing the privacy, security, & data quality for users of HMIS, & ensure that HMIS complies with HUD & CoC standards.2.) Establish ways to encourage the leveraging of housing resources with homeless services programs/organizations
- 5.Rating, Ranking, & Evaluation: review and revise the rating & ranking process to include a stronger tie to project evaluations and collaboration with our DEI workgroup.
- 6.Professional Development & Staff Training: Improve professional development and training availability for staff and volunteers, such as case managers, board members, and stakeholders. Progress toward the goals & objectives of the CoC will be used to monitor the performance of the CoC Director, who performs the designated tasks. Monthly reports will be provided to the CoC/Alliance on progress, & an annual report will be issued. Activities will be recorded as minutes, & updates are provided through members' bimonthly CoC meetings. The members will continue to meet as often as needed to discuss & direct yearly goals to promote the vision and mission of the group & that of the CoC.

Action Plan Summary:

Main committees & workgroups: Strategic Planning, Membership – Lived Experience Advisory Board, Rating, Ranking, & Evaluation, Assessment, Housing, and Professional Development.

First Quarter: January – March 2025

Each group will establish its structure, goals, & outcomes as they fit with CoC's overall structure and governance. They will assign ownership of tasks toward completing group goals & outcomes & define the most significant goals to achieve for 2025.

The System Performance study focused on reducing the Length of Time (LOTH) and Returns to Homelessness (RH) & will now review the results of the community focus groups & interviews conducted in 2024.

Housing will determine the direction they will take during 2024.

RR&E will begin to identify challenges and adjustments to new project application forms and scoring tools. It will also work with DEI to strengthen the DEI portion of the scoring process and determine the best measures for performance evaluation.

DEI – work with RR&E to tighten up the DEI portion of the scoring tool for CoC competition; expand work done in 2024 to organize a Lived Experience Advisory Board, including active recruiting of members; develop a DEI tool for organizations requesting assistance in writing their own agency's statement that complements the CoC statement.

Second Quarter: April – June 2025

Continued follow-up on ownership of tasks towards completion of group goals is redistributed as necessary to continue focusing on the group's mission, vision, values of members as related to the CoC's overall structure & governance. They will review & assess their first quarter activities & revise where necessary to achieve their chosen outcomes and measures.

Third Quarter: July – September 2025

Committees and Workgroups will continue to follow on ownership of tasks towards completion of group goals to be sure they are focused on the group's mission, vision, and values of members and in harmony with the CoC's overall structure and governance. They will review & assess second-quarter activities & revise where necessary to continue to focus on established priorities. Each committee & workgroup will distribute a short anonymous questionnaire on lived experience committee/workshop membership. Committee/workshop Chairs written report on results to CoC Director (different from advisory board membership)

Fourth Quarter: October – December 2025

Committees and Workgroups will review third-quarter activities & report their accomplishments from the year's activities to the Leadership Council & CoC membership. They will solicit feedback from committees, workgroup members, & the larger CoC membership, & begin next year's plans.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

Funds will be used to evaluate the outcomes of COC and ESG projects. Activities will include consultation with the 2 ESG jurisdictions regarding the allocation of ESG funds, development of the ESG applications and certification plans for applicants, ensuring compliance with COC policies, monitoring and evaluating project performance using HMIS-generated reports, and establishing goals, standards, and performance criteria for ESG projects that are consistent with CoC goals, standards, and performance criteria.

Monitoring of CoC projects will be coordinated with the HUD Field Office and ESG monitoring with the Lead Agency Applicant for the State of Wisconsin and the City of Racine ESG. Funding under this planning grant will allow for increased Technical Assistance to projects to clarify Coordinated Entry (CE) reporting requirements, Housing First philosophy, and record-keeping required for proper documentation.

The CoC Director will continue to work closely with CoC committees to ensure that goals and objectives are met and that new initiatives are implemented as planned.
